August 4, 2021

The Board of Trustees of the Texas Southmost College District convened in open session on August 4, 2021 at 5:30 p.m. Board Members present were Mr. Ruben Herrera, Chair; Ms. Eva Alejandro, Secretary; Mr. J.J. De Leon; Ms. Alejandra Aldrete; and Mrs. Delia Saenz. Also present was Dr. Jesús Roberto Rodríguez, President of Texas Southmost College. Absent trustees included Dr. Tony Zavaleta, Vice Chair and Mrs. Adela Garza.

1. Call to Order

The meeting was called to order by Chair Herrera at 6:16 p.m. He called role and confirmed a quorum.

Chair Herrera asked if there were any speakers signed up for public comment. There were no public speakers.

4. Consideration and possible action on the proposed TSC District Tax Rate and schedule of Public Hearing

Dr. Gisela Figueroa, Vice President of Finance and Administration was called upon to present the item. She reviewed the two components of the tax rate, and the three tax rate calculations: Prior Year Rate, No-New-Revenue Rate, and Voter-Approval Rate. She said the administration recommended adopting the Voter-Approval rate of \$0.154636 per \$100 of valuation, which is a decrease from the current year's rate of \$0.162407 per \$100 of valuation.

Chair Herrera made a motion to adopt the Voter-Approval rate of \$0.154636 per \$100 of valuation. Mr. De Leon seconded the motion. As required by statue, Chair Herrera took a roll call vote, and the motion passed unanimously.
