a. Child Care Facilities - locations where services to minors are provided.

b. Patient Care Facilities - locations where health care, counseling, or mental health services are provided.

- d. **Watercrafts** - concealed handguns are prohibited onboard all vessels and watercrafts owned, leased or operated by TSC.
- e. **By Contract** - where state and federal law or contract, at the sole discretion of the state or federal government or organization with whom the contract is entered, requires exclusion of a handgun in a specific location and the exclusion does not generally prohibit or have the effect of prohibiting license holders from carrying concealed handguns on the TSC campus

- g. **Security Office** - in a non-public, secure portion of the College Security Facility used to conduct official business as prohibited under Section 411.207 (b) of the Texas Government Code

- h. **Intercollegiate / Athletic Events** - at a location where high school, collegiate, or professional sporting events or interscholastic event is taking place as prohibited under Section 46.035(b)(2) of the Texas Penal Code, or where a sports club or intramural athletic competition is taking place.
