Results:

Texas Southmost College (TSC) regularly tracks enrollment headcount through the Office of Institutional Research. This data tracking originated from the TSC Strategic Plan – Vision 2026 Strategic Plan, and continues to be part of the FY26 Strategic Priorities. Institutional data for this outcome was compiled from Texas Higher Education Coordinating Board (THECB), Accountability System Reports (2016 – 2025) for Texas Community, Technical, and State Colleges. The most recent Fall 2025 data was compiled from the certified THECB CBM0C1 Student Census Report – institutional data files.

Table 1 shows a steady increase on the on-campus enrollment in the first three years where the target was achieved. This positive trend was visible up until the year of the COVID pandemic (2020). In the last six years (during and after COVID) the on-campus student enrollment shifted to decline. The Fall 2025 shows the lowest percent change of -1.5% when compared to its previous Fall.

Table 2 shows this negative trend of -7.8% as the overall 10th year percent change from Fall 2016 to Fall 2025. This negative trend was higher on the Males (-9.3%) than on the Females (-6.6%).
