Minutes of the Public Hearing and Regular Meeting of the Board of Trustees

August 17, 2023

The Board of Trustees of the Texas Southmost College District convened in open session on August 17, 2023 at 5:30 p.m. Board Members present were Ms. Adela Garza, Chair; Mr. J.J. De Leon, Vice Chair; Ms. Alejandra Aldrete, Secretary; Ms. Eva Alejandro; Mrs. Delia Saenz; and Dr. Tony Zavaleta. Also present was Dr. Jesús Roberto Rodríguez, President of Texas Southmost College. Absent was Mr. Ruben Herrera, Immediate Past Chair.

PUBLIC HEARING AGENDA

1. Call to Order

The public hearing was called to order by Chair Garza at 5:30 p.m. She called role and confirmed a quorum.

2. Pledges of Allegiance

Trustee Alejandro led the United States Pledge of Allegiance and the Texas Pledge of Allegiance.

3. Public Hearing on proposed 2023 Ad Valorem Tax Rate for Texas Southmost College District

Chair Garza reviewed the proposed tax rates: Maintenance and Operations of \$0.097081 and Debt Service of \$0.022686 per \$100 of valuation, which is lower than the current rate. She also reviewed the legal posting of the tax rate and asked for any public comment regarding the tax rate. There were no public speakers.

4. Adjournment of Public Hearing

Trustee Alejandro made motion to adjourn the public hearing. Vice Chair De Leon seconded the motion, which passed unamously. The meeting was adjourned at 5:35.

REGULAR MEETING AGENDA

1. Call to Order

The regular meeting of the Texas Southmost College Board of Trustees was called to order by Chair Garza at 5:36 p.m. She called role and confirmed a quorum.

2. Pledges of Allegiance

Since Trustee Alejandro led the pledges of allegiance during the Public Hearing, they were not recited again during the regular meeting.

3. Public Comment

Chair Garza asked if there were any speakers signed up for public comment. There were no public speakers.

4. President's Report

Chair Garza first provided updates for several items.

President awarded ACCT award

Madam Chair congratulated President Rodríguez for being recognized with the 2023 Western Regional CEO Award by the Association of Community College Trustees. This national award is only one of five bestowed annually to CEOs by the organization, one for each of its five regions across the United States and Canada. Dr. Rodríguez was recognized for his exceptional work in initiating or helping to develop innovative programs as models for use in two-year postsecondary institutions. She added that the board has long been proud of President Rodríguez's work at Texas Southmost College, and it is very affirming for him to be recognized. The board looks forward to celebrating him at the Annual ACCT Awards Gala in October.

CCATT Trustee Leadership Seminar

Madam Chair, Vice Chair De Leon and Secretary Aldrete attended the Community College Association of Texas Trustees Trustee Leadership Seminar in McAllen, on June 23rd. She said it was a very productive seminar.

NALEO 40th Annual Conference in NY

Madam Chair, Vice Chair De Leon, and Immediate Past Chair Herrera attended the National Association of Latino Elected Officials 49th Annual Conference from July 10th through 13th. She said it provided an excellent opportunity to network with peers, as well as elected officials at all levels.

Legislative Updates by Senator LaMantia

Madam Chair and Trustee Saenz attended a Legislative Update by Senator LaMantia hosted by the Harlingen Chamber of Commerce on July 18th. Senator LaMantia provided an update of bills passed in the 88th Texas Legislature.

Chair Garza then called on President Rodríguez to present his report.

President Rodríguez noted that the ACCT CEO award he received is an achievement based on the collective efforts of the Board of Trustees and the great faculty and staff that works hand-in-hand to achieve the Board's vision.

PCT High Demand Job Training check presentation & new cohort

Texas Southmost College hosted the Texas Workforce Commission (TWC) High Demand Job Training grant program check presentation ceremonies on July 27th. This program funded scholarships in TSC's Patient Care Technician program, which TSC designed in response to industry demand for a next-generation entry point for healthcare professionals. Because of the high demand, Workforce Solutions Cameron and the Greater Brownsville Incentives Corporation allocated \$297,000 for student scholarships. Madam Chair and President Rodríguez provided remarks at the event, joined by the Texas Workforce Commissioner representing labor, Mr. Alberto Trevino III.

JET Grant check presentation

TSC also hosted the Texas Workforce Commission announcement for JET grant funding on August 10th, and Madam Chair and President Rodríguez provided remarks at the event. TSC received \$331,292 to fund equipment in the Industrial Mechanics and Maintenance Technology program. In addition, TSC was the higher education partner for two school districts: Jubilee Academy, which was funded for their Vocational Nursing program, and Point Isabel School district, who was funded for their Construction Manager program. Following the presentation, a number of TSC's school partners took part in a back-to-school reception, during which the college hosted superintendents and CTE administrators from Harlingen, Jubilee Academies, St. Joseph Academy, La Feria, Point Isabel, Rio Hondo, San Benito, and La Sara.

SDF Rich Products Grant check presentation

President Rodríguez, Madam Chair, and Trustee Saenz also participated in the Texas Workforce Commission presentation of the \$132,000 Skills Development Grant awarded the TSC and Rich Products on August 10th. Through the project, TSC provided a wide-range of topics including Programmable Logic Controller, Welding, Forklift, OSHA, Fire Prevention, and Professional Communication. President Rodríguez thanked Madam Chair and Trustee Saenz for participating in the event, as well as the grants team and workforce faculty and staff who delivered the training.

La Feria H.S. Name Change Celebration

Texas Southmost College was recognized as the La Feria Independent School District's dual enrollment partner at the high school's name change celebration, as the school officially became La Feria Early College High School. The event featured this year's high school seniors, who will be the very first students from La Feria to earn an associate's degree through TSC's dual enrollment program. President Rodríguez thanked Vanessa Vasquez, Jose Arambul, and Sarai Juarez for representing TSC at the event.

New Ventanilla Kiosk Ribbon Cutting

President Rodríguez and Madam Chair participated in a ribbon cutting with the Mexican Consulate of Brownsville for the updated information kiosk at the ITEC Center. The Consul's office funds a TSC student employee recruiter to manage the kiosk and provide information to community members

about Apply Texas, scholarships, registration, and other information about Texas Southmost College. In addition, the student employee is cross-trained to assist potential international students with securing the documents they need to register at TSC. This partnership was the first of its kind, and is now being replicated with other Mexican Consulate offices. President Rodríguez expressed his appreciation of the strong relationship TSC has with consul Juan Carlos Cue Vega.

TSC Mariachi Camp and Mariachi Escorpion auditions

TSC hosted its first Mariachi summer camp for high school students July 10-12 at the TSC Performing Arts Center. Approximately 30 students were immersed in the rich traditions of mariachi music and took part in a concert at the conclusion of the camp. President Rodríguez thanked Madam Chair, Secretary Aldrete, Trustee Saenz and Trustee Alejandro for participating in the event.

Auditions for the TSC Mariachi Escorpion ensemble were held later in July with ensemble members coming from the current TSC student body, as well as incoming freshmen from local high schools. One more round of auditions will be held once fall classes begin.

Enrollment Services Extended Hours

Enrollment continues for the fall semester, and the Enrollment Services division extended hours of operation to better serve the community. During the month of August, Enrollment Services offices were open until 7pm Monday, Tuesday, and Thursday, and until 8pm on Wednesdays. They were also open on Saturdays from 10am to 2pm. President Rodríguez thanked Ms. Vanessa Vasquez and her entire team for the outstanding effort they put forth.

Scorpion Success Orientation

Scorpion Success Orientation sessions were held August 4th and 5th. Employees from a wide-array of campus divisions engaged with students to ensure they are energized and prepared to start the semester Scorpion Strong.

NJCAA Soccer

TSC's National Junior College Athletic Association league season kickoff will take place Friday, September 1st at Scorpion Field. The men's and women's teams will take on Trinity Valley Community College. The next day, the men's and women's teams will play Tyler Junior College. Saturday is also designated as Scorpion Family Day, and the players will be presented on the field with their loved ones.

Nursing Program New Student Boot Camp

The Vocational Nursing and Associate Degree Nursing programs teamed up to restructure their programs' new student orientation. They held the Nursing Program New Student Boot Camp on August 1st-3rd, when students were able to interact with faculty and Student Services staff. The students' family members attended a session on the final day, during which they were briefed on their students' schedules and what to expect during the program. The boot camp strengthened the nursing student cohort, and the program has received great feedback from the participants.

CJI Graduation

Fifteen students graduated from the Criminal Justice Institute on July 22nd. Cameron County District Attorney, Mr. Luis Saenz, served as the keynote speaker, providing words of advice to the graduates. President Rodríguez thanked Madam Chair and Trustee Saenz for participating in the ceremony.

Scaffolding graduation

The following week, WTCE also graduated the most recent cohort from the Industrial Scaffolding program. BrandSafeway's CEO, Mr. Robert Bel, was the keynote speaker at the ceremony, during which he hired every single one of the graduates. The students graduated on Friday, and began their new jobs on Monday. President Rodríguez thanked Madam Chair for participating in the ceremony.

TSC LVN Pinning Ceremony

The Vocational Nursing program graduates were honored during their pinning ceremony on August 11th. The students represented a wide array of ages and experience, which brought a great depth to the class. Most of them worked in the healthcare field at the same time they were perusing their certification, and their employers provided great support and flexibility as they engaged in their coursework.

Orbital Tube Welding

The first Orbital Tube Welding course was held this summer, as part the collaboration with the Texas A&M Engineering Extension Service. Two student cohorts began classes at ITECC in July, and they will complete the course September 6^{th} .

Oscar Hernandez Learning Technology Appointment

Mr. Oscar Hernandez, Associate Vice President of Institutional Effectiveness and Educational Technologies, has been appointed to serve on the Learning Technology Advisory Committee (LTAC) of the Texas Higher Education Coordinating Board. During his three-year term, he will engage in policy research and discussion regarding the important role that learning technology plays in Texas higher education. The committee will also provide the THECB with advice and recommendations regarding learning technology. President Rodríguez thanked Mr. Hernandez for accepting the appointment and for sharing his expertise with colleagues across the state.

Forensic Macro Photography

Texas Southmost College continues to be the only institution of higher education to offer a Forensic Macro Photography course, and now this work is being shared on a global scale. Criminal Justice Institute Adjunct Instructor Thomas Kimbriel traveled to India to teach the course at the National Forensic Sciences University - Delhi Campus. His work was sponsored by the International Committee of the Red Cross. After his return, Mr. Kimbriel was invited to serve as an external reviewer for a research project by the university's dean, and he looks forward to strengthening this collaboration.

Video Presentation

President Rodríguez shared a video highlighting college activities since the last regular board meeting.

President Rodríguez thanked the Board for their continued support and commitment to the communities TSC serves, as well as the TSC faculty and staff for their hard work and dedication in starting off the new academic year Scorpion Strong.

Madam Chair stated that the whole board wanted to recognize the dedicated work of the college employees with the salary increase.

Secretary Aldrete made a motion to approve the Texas Southmost College Fiscal Year 2023-2024 Operating Budget, with a six percent salary increase to all employees, as presented. Trustee Alejandro seconded the motion, which carried unanimously.

7. Consideration and possible action on the adoption of the 2023 TSC District Ad Valorem Tax Rates Resolution.

Dr. Gisela Figueroa, Vice President of Finance and Administration, was called on to present the item. She reviewed the property tax rate components, tax rate calculations. The proposed tax rate is a reduction of \$25.15 per \$100,000 of valuation from the previous year.

Vice Chair De Leon made a motion to adopt a maintenance and operations tax rate of \$0.097081 and a debt tax rate of \$0.022686 per \$100 of valuation. Secretary Aldrete seconded the motion, which carried unanimously.

A motion was made by Trustee Zavaleta to approve an MOU with Our Lady of the Lake University and authorize President Rodríguez to sign the agreement. Trustee Saenz seconded the motion, which carried unanimously.

g. Consideration and possible action to approve a Memorandum of Understanding with Sam Houston State University

Ms. Vanessa Vasquez, Interim Associate Vice President of Student Services, was called upon to present the item. The proposed MOU provides a direct pathway for TSC students to transfer to SHSU, and supports the cooperation of SHSU's and TSC's advising and mentoring teams to work collaboratively.

A motion was made by Trustee Zavaleta to approve an MOU with Sam Houston State University and authorize President Rodríguez to sign the agreement. Trustee Saenz seconded the motion, which carried unanimously.

h. Consideration and possible action on approval of updating the matching grant support for the AmeriCorps Texas Operational grant

Dr. Angelica Fuentes, Associate Vice President of Workforce Training and Continuing Education, and Dr. Angela McCauley, Director of Special Projects, were called upon to present the item. The proposed item would authorize an increase in TSC's matching funds for the AmeriCorps VISTA grant, in response to a living allowance increase for VISTA members instated by the grant program.

A motion was made by Trustee Zavaleta to approve an increase in matching grant support to total \$22,880 for the 2023-2024 TSC AmeriCorps VISTA grant project. Vice Chair De Leon seconded the motion, which carried unanimously.

11. Facilities Committee

Chair Garza called on Secretary Aldrete to present the report.

a. Consideration and possible action on award RFP 23-22 for "Dedicated Chiller Plants for TSC Recreation and Child Care Centers"

Dr. Gisela Figueroa, Vice President of Finance and Administration, was called upon to present the item. She reviewed the RFP timeline, scope of work, evaluation committee, pricing and scoring, review criteria, and budget and financial impact. There were two respondents to the RFP, with ZIWA Corporation receiving the highest score from the committee.

A motion was made by Secretary Aldrete to award RFP 23-22 for "Dedicated Chiller Plants for TSC Recreation and Child Care Centers" to ZIWA Corporation in the amount of \$2,575,000 and authorize President Rodríguez to execute the contract, as presented. Trustee Alejandro seconded the motion, which carried unanimously.

b. Consideration and possible action on award RFP 23-23 for "Thermal Plant Chiller Equipment"

Dr. Gisela Figueroa, Vice President of Finance and Administration, was called upon to present the item. She reviewed the RFP timeline, scope of work, evaluation committee, pricing tabulation, review criteria, and budget and financial impact. There were three respondents to the RFP, with Texas Air Systems, LLC receiving the highest score from the committee.

A motion was made by Secretary Aldrete to award RFP 23-23 for "Thermal Plant Chiller Equipment" to Texas Air Systems, LLC in the amount of \$1,090,234 and authorize President Rodríguez to execute the purchase order contract, as presented. Vice Chair De Leon seconded the motion, which carried unanimously.

c. Consideration and possible action on award RFP 23-24 for "Thermal Plant Cooling Tower Equipment"

Dr. Gisela Figueroa, Vice President of Finance and Administration, was called upon to present the item. She reviewed the RFP timeline, scope of work, evaluation committee, pricing tabulation, evaluation criteria, and budget and financial impact. There were two respondents to the RFP, with Perry Mechanical Systems, LLC receiving the highest score from the committee.

A motion was made by Secretary Aldrete award RFP 23-24 for "Thermal Plant Cooling Tower Equipment" to Perry Mechanical Systems, LLC in the amount of \$959,685 and authorize President Rodríguez to execute the contract, as presented. Vice Chair De Leon seconded the motion, which carried unanimously.
