5. Consideration and possible action on the proposed TSC District Tax Rate and schedule of Public Hearing

Dr. Gisela Figueroa, Vice President of Finance and Administration, was called on to present the agenda item. Dr. Figueroa presented three tax rate calculations for the Board's consideration: prior year rate, nonew-revenue rate, and voter-approved tax rate.

The board engaged in a brief discussion of the amount of revenue that will be raised through the voter-approved tax rate.

Chair Garza polled each board member for their vote on the rate. All board members voted for a proposed voter-approved tax rate of \$0.144916 per \$100 of valuation which carried unanimously.

Trustee Saenz made a motion to schedule a public hearing on August 18. Immediate Past Chair Herrera seconded the motion, which carried unanimously.

6. Consideration and possible action on approval of diesel truck purchase

Dr. Joanna Kile, Vice President of Workforce Training and Continuing Education, and Dr. Joseph Fleishman, Associate Vice President of Instruction-Workforce Development, were called upon to present the item. Dr. Kile said the proposed item would be purchased through the Texas Reskilling and Upskilling for Education (TRUE) Institutional Capacity grant, and has been approved by the funding agency. Dr. Fleishman reviewed the vendors who submitted bids for the truck and the expected delivery dates.

A motion was made by Vice Chair De Leon to approve the diesel truck purchase for the Diesel program from Boswell Elliff Ford in the amount of \$69,000 through TIPS contract number 210907 and authorize President Rodríguez to execute the purchase order contract, as presented. Secretary Aldrete seconded the motion, which carried unanimously.

Consideration and possible action on approval of vehicle column lift purchase from Grainger

Dr. Joanna Kile, Vice President of Workforce Training and Continuing Education, and Dr. Joseph Fleishman, Associate Vice President of Instruction-Workforce Development, were called upon to present the item. Dr. Kile said the proposed equipment would be purchased through the Texas Reskilling and Upskilling for Education (TRUE) Institutional Capacity grant, and has been approved by the funding agency. Dr. Fleishman reviewed the proposed equipment, as well as the vendors who submitted bids and the expected delivery dates.

A motion was made by Trustee Alejandro to approve vehicle column lift purchase for the Diesel program from Grainger in the amount of \$56,000 through OMNIA Partners purchasing cooperative and authorize President Rodríguez to execute the purchase order contract, as presented. Trustee Saenz seconded the motion, which carried unanimously.
