Minutes of the Regular Meeting of the Board of Trustees

October 26, 2023

The Board of Trustees of the Texas Southmost College District convened in open session on October 26, 2023 at 5:30 p.m. Board Members present were Ms. Adela Garza, Chair; Mr. J.J. De Leon, Vice Chair; Ms. Alejandra Aldrete, Secretary; Mr. Ruben Herrera, Immediate Past Chair; Ms. Eva Alejandro; and Mrs. Delia Saenz. Also present was Dr. Jesús Roberto Rodríguez, President of Texas Southmost College. Absent was Dr. Tony Zavaleta.

REGULAR MEETING AGENDA

1. Call to Order

The meeting was called to order by Chair Garza at 5:30 p.m. She called role and confirmed a quorum.

2. Pledges of Allegiance

Trustee Alejandro led the United States Pledge of Allegiance and the Texas Pledge of Allegiance.

3. Public Comment

Chair Garza asked if there were any speakers signed up for public comment. There were no public speakers.

4. President's Report

Chair Garza first presented the following item:

ACCT Leadership Congress

Chair Garza reported on TSC's participation in the Association of Community College Trustees convening held October 9-12. TSC delegates attending included Chair Garza, Vice Chair De Leon, and Trustee Alejandro, President Rodríguez, Dr. Figueroa, Dr. Garcia, Mr. Villarreal, and Dr. McCormack.

Chair Garza noted that the event is the nation's largest professional development opportunity for college trustees, presidents, and other members of leadership. The TSC team networked with nationally renowned keynote speakers and attend presentations. President Rodríguez was also recognized as winner of the 2023 Western Regional CEO Award.

Chair Garza called on President Rodríguez to present his report.

President Rodríguez thanked Madam Chair for her report and said that the ACCT recognition is a reflection of the dedicated work of the TSC community, inclusive of the work of the Board of Trustees, faculty, staff, and the TSC Foundation.

Spring Registration

Registration is underway for the spring semester, and the TSC campus community is hosting a number of outreach events to engage current and potential students. Coaches have been meeting with students across campus, making it as convenient as possible for them to enroll for the Spring Semester. In addition, coaches have been participating in community events, such as Living History Day and the upcoming Haunted Grounds tours. Campaigns are also underway to promote workforce training programs at ITECC, as well as academic courses to be offered in Harlingen.

Annual Vendor Seminar

TSC's Purchasing Department held the 4th annual TSC Vendor Seminar on September 27th, with approximately 60 participants in attendance. The event featured key information on how to do business with Texas Southmost College, including topics such as how to register as a vendor, the procurement process, contract awards, and even corporate giving. President Rodríguez thanked the Purchasing Department team for their important outreach to our business community.

Living History Day

TSC held its 6th Annual Living History Day on October 21st. The event was well attended, serving as an opportunity for the community to get to know the TSC campus and its unique place in history. In addition, the event serves as a recruitment effort, as community members learn about the college's programs and interact with faculty, staff, students, and Trustees. President Rodríguez thanked Chair Garza, Vice-Chair De Leon, and Secretary Aldrete for participating in the event.

Domestic Violence Awareness event

TSC partnered with the Cameron County District Attorney's office to host TSC's 6th annual Domestic Violence Awareness event on October 18th. More than 250 students, faculty, staff, and community members participated in the event, during which they learned about the signs of domestic violence and how to get help. President Rodríguez thanked District Attorney Luis Saenz, and the Cameron County DA's office, as well as Dr. Chris Alves and the TSC's student Law and Legal Society, for making the event a success.

Scorpion Classic Golf Tournament

TSC held its 3rd annual Scorpion Classic Golf Tournament on October 14th at the Rancho Viejo Resort, with a terrific showing from community supporters, including vendors, donors, and friends of TSC. President Rodríguez noted that the nice weather affirmed the college's good decision to move the tournament to October. He thanked a number of individuals for their dedicated work in ensuring the event ran smoothly. Among them were:

 The TSC Foundation Golf committee which includes: Secretary Alejandra Aldrete, Joey Camacho, and Roel Rodríguez;

- Foundation Chair Roy De los Santos, for providing the welcome and serving as master of ceremony at the Awards Luncheon;
- Foundation Secretary Norma Hinojosa, Foundation member Joey Camacho, and Chair Garza and Vice Chair De Leon--who represent both the TSC Board of Trustees and the Foundation Board-- for giving of their time and participating in the events;
- The record number of volunteers this year from TSC's faculty, staff and students, who helped make the event a success; and
- All of the sponsors and donors, for their continued support.

President Rodríguez reported that donations for student scholarships are still coming in, and he expects to have a final tally in the coming weeks.

Video Presentation

President Rodríguez shared a video highlighting college activities since the last regular board meeting.

Rotary Club

The Rotary Club of Brownsville Sunrise presented a \$5,000 donation for student scholarships. The delegation, which included Mari Montelongo, Dalilah Garcia, Mary Elizabeth Hollmann, and George Olivo, thanked the Trustees for their collaboration on their parking fundraising project at ITECC.

Health Professions and WTCE updates

President Rodríguez called on Dr. Brian McCormack, Interim Vice President of Instruction, and Mr. Richard Mesquias, Vice President of External Relations and Workforce Development, to present information on the Health Professions and Workforce Training programs, as a follow up to previous meetings.

Dr. McCormack presented data from the past five years for Health Professions programs, including Associate Degree Nursing, Licensed Vocational Nursing, Diagnostic Medical Sonography, Radiologic Technology, Emergency Medical Science, Medical Laboratory Technology, and Respiratory Care Sciences. He noted that all programs are accredited and in good standing. The board engaged in a brief discussion of the high quality instruction students receive and their time spent in clinical settings.

Mr. Mesquias presented data the college's welding programs, for which TSC awards certificates of completion. He noted that TSC is also a host site for American Welding Society testing. While the tests are administered by a third party, instructors encourage workforce training students to take the tests and noted the test is not required for employment. The board engaged in a brief discussion of welding training options at TSC.

President Rodríguez thanked the Board of Trustees for their support and guidance, and he thanked the faculty and staff in preparing for a strong spring semester.
