SIGNIFICANT EXTERNALITIES

Texas Southmost College (TSC) is located in the Lower Rio Grande Valley, an area that is economically and educational challenged, where approximately 94% of the population is Hispanic. The TSC supports initiatives for achieving the goals of the 60X30TX program initiated by the Texas Higher Education Coordinating Board. TSC has a high impact in the economy of the Rio Grande Valley since we serve a young population. The age of the population in this area under 18 years of age is 40.6% compared to national average of 28.7%. The colleges continue to expand offerings for work force students and partners in the local economy to provide workers with the skills needed for employment. TSC responds to business, industry, and community needs through updated and new programs such welding, plumbing, pipefitting, insulation, scaffolding, criminal justice academy, dual enrollment CNA certifications.

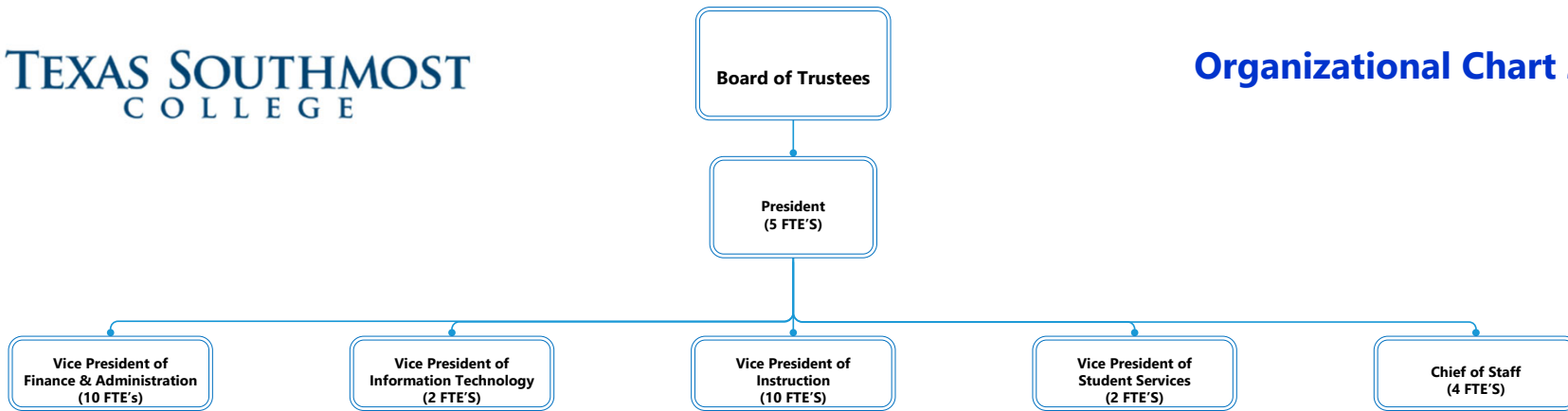
Texas Southmost College (TSC) is proposing a Workforce Center for Border Security to build a multi-faceted program aimed at developing a skilled workforce capable of serving the diverse needs of Texas and the Rio Grande Valley. The Center will focus on workforce skills for interdisciplinary field operations including: (1) cybersecurity, (2) border protection/law enforcement, and (3) immigration services.

This request is for support funding to finalize the creation of the Workforce Center for Board Security. During the past couple of years, TSC has invested in this initiative by building a Criminal Justice Institute Simulation Center. This state-of-the-art facility that will be configured to support the comprehensive training needs of law enforcement of the Rio Grande Valley. TSC has also been working on the creation of a Fusion Center. The Fusion Center is partnership from local, state, and federal law enforcement agencies with Texas Southmost College. The Fusion Center will bring law enforcement agencies together to collaborate in training and sharing of information. Both of these two initiatives are almost complete and will be fully operational in the next few months.

Community College Funding request

Texas Southmost College District respectfully supports the \$1.83 billion formula funding request submitted by the Texas Association of Community Colleges (TACC) in its letter to the Legislative Budget Board and the Governor's Office, Budget Division. State support remains critical to the district as it continues to fulfil its statutory role and mission to offer vocational, technical, and academic courses for certification or associate degrees. Together with Texas' other 49 community college districts, we will continue do much of the heavy lifting in the state's efforts to achieve the 60X30TX plan. State support will further be necessary to help address costs related to mitigating the effects of the pandemic, including transitioning to distance education, providing for personal protective equipment, and safely delivering the required in-person instruction essential for students in healthcare and other technical/vocational programs.

In response to the economic downturn resulting from the COVID-19 pandemic, Texas community colleges began developing a workforce initiative aimed at providing low or no-cost short-term workforce training leading to high-demand credentials to Texans whose employment and/or academics had been recently disrupted. Texas Southmost College District respectfully supports the \$50M exceptional item request submitted by TACC in support of this statewide workforce initiative, funded in the amount of \$1M per college district for the 2022-23 biennium.

DESCRIPTION / JUSTIFICATION:

The mission of Texas Southmost College's proposed Workforce Center for Border Security is to build a multi -faceted program aimed at developing a skilled workforce capable of serving the diverse needs of Texas and its Rio Grande Valley and northern Tamaulipas border region. The Center will focus on workforce skills for interdisciplinary field operations including: (1) cybersecurity, (2) border protection/law enforcement, and (3) immigration services.

EXTERNAL/INTERNAL FACTORS:

1. Cybersecurity: TSC seeks to develop an Associate of Applied Science in Cybersecurity and a Certificate of Proficiency Level One in Cybersecurity to prepare the next generation of specialists who will meet the ever-changing demands of the cybersecurity industry on the border. The AAS degree will include coursework in network administration, databases, digital forensics, Linux installation and configuration, computer virtualization, implementing and supporting servers, and wireless security; and the certificate program will include coursework in networking, databases, digital forensics, and Linux installation and configuration.
2. Border protection/law enforcement: The Criminal Justice Institute at Texas Southmost College is a fully licensed state law enforcement training entity with a mission to provide a complete array of training for state and federally licensed law enforcement and correctional personnel, as well as a variety of courses designed to train the general public on public safety issues.
3. Immigration services: TSC offers an AAS Social Work degree grounded in foundational social work concepts. The program is designed to help students develop a strong foundation in social work values and ethics, comprised of courses that emphasize critical thinking and problem-solving skills. With this funding, a specialized track will be designed to build workforce capacity to provide immigration and social services for the unique population along the Texas -Mexico border. Students will engage in external learning experiences where they will apply the skills they are learning in the classroom in real-life settings. This track will prepare students to work with a variety of populations, such as unaccompanied minors, asylum seekers, and refugees.
