## Emergency Tuition Loan

- Emergency tuition loans are for tuition and mandatory fees only (not for books, supplies, etc.).
- The Emergency Tuition Loan protects your classes, as long as the tuition charges amount is larger than your Emergency Loan. If you decide later in not to attend, you must drop your classes with the Office of Admissions & Records or thru MyTSCOnline.edu. Charges will apply if you drop on or after the first day of class.
- Student can have either a payment plan or an emergency loan, not both.
- Emergency loan payment due in full by February 4, 2022.
- The maximum loan amount will not exceed \$500.

### Requirements for Emergency Loans:

- Student must apply first at Financial Aid Office or go to [www.fafsa.gov](http://www.fafsa.gov) and have completed ALL Financial Aid paperwork;
- Be in good academic standing (cumulative GPA 2.0 or higher);
- Be enrolled for six or more credit hours;
- Have a zero balance with TSC for prior semesters;
- Must not be on Financial Aid suspension.

## Refunds for Withdrawal or Dropped Courses

To avoid tuition charges, review your schedule and make necessary changes prior to the first day of class of the semester.
